HERE'S A RECAP  
of What You Missed



On May 24, 2023, Guam was hit by a powerful typhoon, Typhoon Mawar, with sustained winds of 140 mph that devastated the island's natural beauty, damaged homes and business infrastructures, and left many parts of the island with little to no access to power and water. We know that many of you continued to provide support such as food, shelter, and essential services after the typhoon. We also recognize that while many of you were dealing with your own personal situations, you were there for those individuals and families that were greatly impacted by the storm.

Now that we're back on schedule, here's what you missed: Prior to the typhoon, GCASAFV held its hybrid **KNOW MORE** conference series **Addressing Sexual Assault (SA)/ Domestic Violence (DV)** and **Journey to Healing**. Trainers from national Technical Assistance (TA) providers – National Organization of Asian Pacific Islanders Ending Sexual Violence (NAPIESV), Minnesota Indian Women's Sexual Assault Coalition (MIWSAC), AEquitas, and Stalking Prevention Awareness Resource Center (SPARC) – conducted sessions covering issues that addressed stalking, trauma-informed prosecution, and sexual assault in API and native communities, SA framework to healing through cultural lens, safety, justice, and healing in native communities. GCASAFV also appreciates the support of our island partners who facilitated training sessions on various topics, including Judge Arthur Barcinas, Nadine Cepeda, Pale' Mike Crisostomo, Guam Police Department's Domestic Assault Response Team, West Care Pacific Islands, and Susan Marie Aguon. GCASAFV was also fortunate to have Victoria Wynecoop-Abrahamson from the National Center on Domestic Violence Trauma and Mental Health conduct her Zoom presentation on self-care and burnout for advocates and staff who work with domestic violence survivors.

GCASAFV held its Annual Membership Meeting on August 8 to update Coalition members and community partners on GCASAFV's training, technical assistance, and community outreach projects.

- GCASAFV was awarded \$750K for three years from the Department of Justice's Office on Victims of Crime for victim services for human trafficking through its '**Project Setbe yan Protehi**'. This Project aims to build capacity to provide services to victims/survivors of human trafficking.
- The Department of Health & Human Services' Centers for Disease Control and Prevention awarded \$115K for one year to GCASAFV to assess the Coalition's capacity to advance prevention programming.
- With the election of the Vice-Chair, Secretary, and two Directors-at-large closing prior to the Annual Meeting, the 2023 slate of Board officers were announced: Chair – Maresa Aguon; Vice-Chair – Antoinette Bautista; Secretary – Nadine Cepeda; Treasurer – Pale' Mike Crisostomo; Directors-at-large – Ansito Walter, Grace Donaldson, Diana Nucum, and Melissa Torres. GCASAFV extends its appreciation to these members for continuing to serve on the Board.

\*\*Through the STOP (Services \* Training \* Officers\* Prosecutors) funding from the Office on Violence Against Women for culturally specific projects through the Governor's Community Outreach – Federal Programs Office (GCO-FPO), GCASAFV is building capacity and providing training to interpreters through its Community Advocates as Interpreters/Translators. GCASAFV plans to provide more skills-building training for its interpreters to support agency partners with ensuring language access to services.

### AOA-SAC's Focus on Addressing Spiritual Abuse

This Conference is in partnership with the Archdiocese of Agana-St. Anthony Church (AOA-SAC) and Guam Human Rights Initiative (GHRI). The two organizations will collaborate with

GCASAFV to facilitate and moderate the conference sessions for this year's *Call to Action: 4R's*.

The Archdiocese of Agana-St. Anthony Church sexual assault program, *Faith Matters!*, joins the GCASAFV and GHRI in their upcoming October *Call to Action: 4R's* Conference 2023.

AOA-SAC aims to RENEW their commitment to coordinate and train clergy, faith-based leaders and respective congregations in creating safe and violence-free communities; to REKINDLE meaningful partnerships with government agencies and non-profit organizations; to REFLECT on coordinated strategies and resources to support victims and their advocates; and to RESPOND with an action plan that is strategic and effective reducing assault and violence in the island's communities.

In partnership with GCASAFV, AOA-SAC will be hosting at the conference a plenary session on the topic of spiritual abuse. Spiritual abuse is no less harmful or difficult to endure than any other kind of abuse, as a person's spiritual life is deeply personal. However, it can be very difficult to identify as many victims may not recognize they are being abused. In addition, the abusive partner may claim that any challenge to the abuse is an assault on their own religious freedom.

The AOA-SAC's featured guest speaker, Cathy Melesky Dante, is a licensed social worker with extensive pastoral, teaching, and social work experience. She has lectured, conducted research, and published articles on topics such as *Power Literacy in Abuse Prevention Education*, *Navigating Spiritual Worldviews: When Beliefs Don't Match*, and on spiritual abuse. She has a bachelor's degree in mathematics, a masters in social work and in divinity, and currently pursuing her doctoral degree in theology and society.

If you feel that you are experiencing spiritual abuse — whether from a religious organization or as an element of intimate partner violence — help is available. You do not need to endure this kind of trauma alone. You deserve to feel safe.

The end goal is that no family member should be left behind, and that every community experiences a safe and violence-free environment.

The API-GBV awarded 41 organizations to implement culturally specific, community-based projects supporting survivors of domestic violence and sexual assault from Asian American and Pacific Islander (AAPI) communities across the U.S. and Pacific. NAPIESV is in partnership with API-GBV to support efforts by working with funded organizations that focus on SV to increase the availability of culturally specific and trauma-informed services to victims/survivors. Through the Family Violence Prevention and Services Act (FVPSA) under the 2021 American Rescue Plan (ARP) initiative, this will be the first time API-GBV will be funding culturally specific organizations that serve sexual assault (SA) and domestic violence (DV) survivors in AAPI communities.

### **Peaceful Heart**

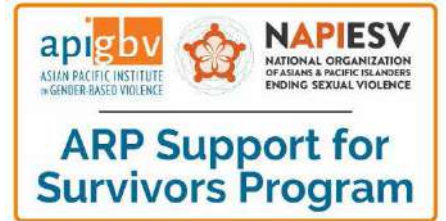
**Location: Bay Area, California**

**The STAR Project** delivers training and information through the Allstate Foundation Moving Ahead Grant on Guam. It aims to support survivors of intimate partner violence/domestic violence with resources and technical assistance so that survivors learn valuable financial skills. GCASAFV's STAR Project aims to support agencies working with DV survivors living with a disability, DV survivors regardless of religious affiliation, are homeless, in shelter programs, and the LGBTQ community. The three organizations will provide technical assistance and resources with implementing financial empowerment and life skills.



## St. Anthony Catholic Church

Through this STAR Project supported by the Allstate Foundation, St. Anthony Catholic Church will provide resources for survivors to become financially independent and live sustainable lives with their family such as: providing education and support in areas of budgeting, job readiness, understanding financial abuse, building financial foundations, and future financial planning. To meet this initiative, St. Anthony Church is hosting a Free Technology Literacy Program to promote computer and email skills, develop online research skills, discover tech online safety, and create spreadsheets and digital designs to survivors.

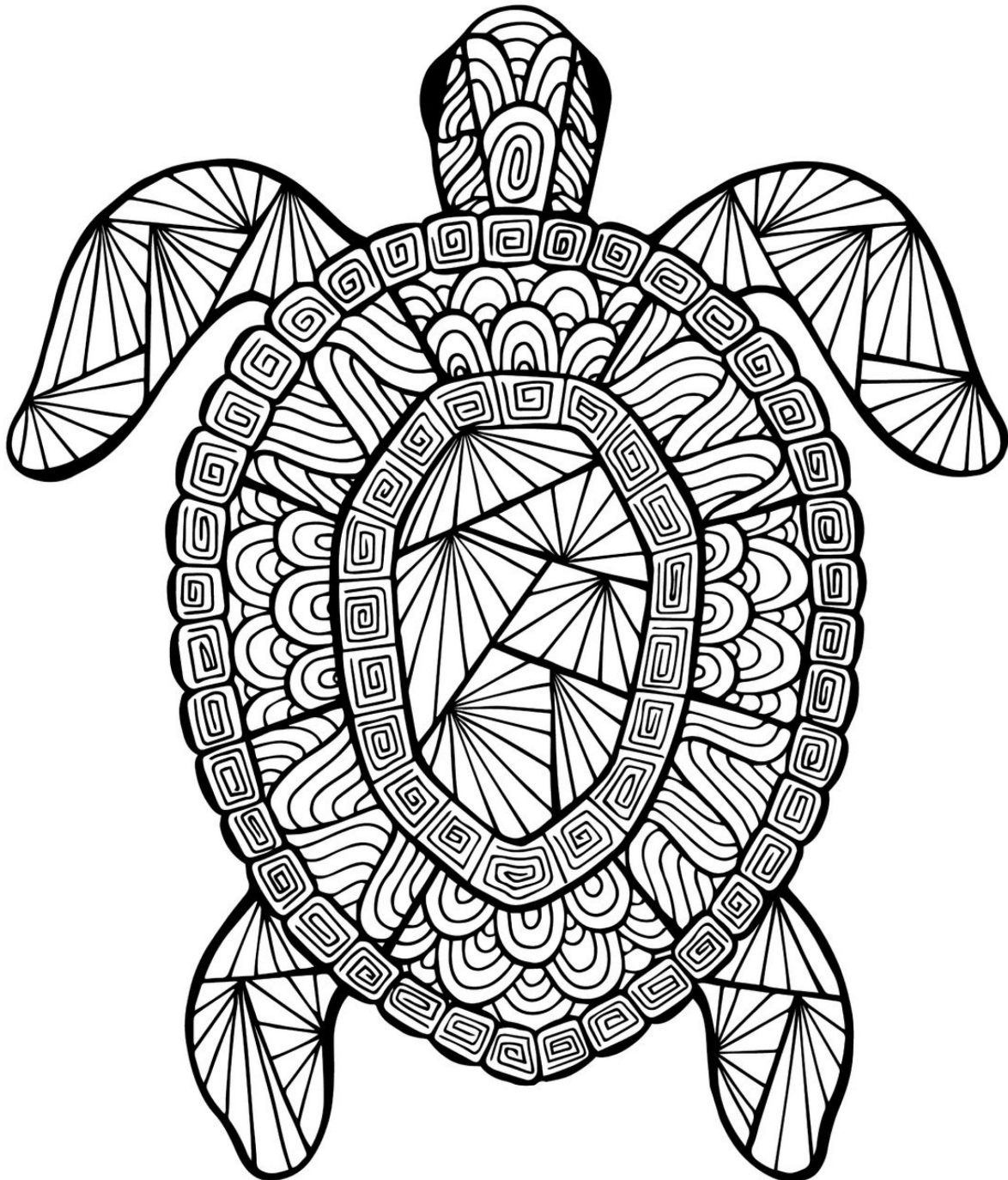
## BALANCE AND HARMONY

### Enjoy this free printout of a *Haggan*!

The CHamoru name for sea turtle is *Haggan*. The *Haggan* is one of the most common species you'll see around Guam's beaches. They are listed as an endangered and threatened species under the Endangered Species Act and are continually protected by marine animal protection programs here in Guam.

The *Haggan* had a complex historical role in CHamoru culture and diet. Traditionally, the meat of the *haggan* would be prepped as a dish, mostly mixed with coconut milk. The shell of the *haggan* would also be used for jewelry to signify a person's status of wealth. Now, it is illegal to catch, kill, or remove a *haggan* from the ocean in order to allow its species to thrive.

The *Haggan* is renowned for their cross-ocean migrations between their foraging grounds and nesting beaches. These intensive migrations span thousands of kilometers across the globe, with many scientists still unsure as to how they navigate the vast ocean. Similar to the *haggan*, the journey to healing is often faced with countless challenges and uncertainties, it can span exuberant amounts of time and for many it is never resolved with a simple solution. Yet, through it all, individuals can overcome them with the willingness to start, education and resources for support, and determination to persevere.
