**January is Human Trafficking and Stalking Awareness Month
Proclamation Signing and Resolution Presentation**

To be held Wednesday, January 10, 2018 3:30pm at the Guam Museum - Multi-Purpose Room

In conjunction with the Governor's Community Outreach – Federal Programs Office, U.S. Attorney's Office for the Districts of Guam and the Northern Mariana Islands, the Guam Coalition Against Sexual Assault & Family Violence (GCASAFV) and its partners cordially extend an invitation to attend the Proclamation Signing and Presentation of Resolutions recognizing January as Human Trafficking and Stalking Awareness Month.

January is nationally recognized as Human Trafficking and Stalking Awareness Month and here on Guam. Efforts are aimed at speaking out against and raising awareness of human trafficking, working to prevent stalking and providing information on services and community awareness and education. Globally, according to some estimates, approximately seventy four percent (74%) of human trafficking involves sexual exploitation; and fourteen percent (14%) involves labor exploitation.

The Proclamation will be presented and signed by the Office of the Governor. The Resolution will be presented by the 34th Guam Legislature.

In addition, a wave will be held after the Proclamation Signing and Resolution Presentation across Chamorro Village along Marine Corps Drive, behind the Guam Museum.
